#### Hi Everyone!

This is the first update to the community regarding the Spring Street Pavement Rehabilitation Project. Preconstruction notifications were distributed to adjacent landowners in early September and are available for viewing on the City's website. Construction is scheduled to begin the week of September 21<sup>st</sup> and be completed mid-November. We will provide construction updates via email to interested parties and post the updates on the City of Placerville's website in an effort to keep the community informed as to the status of this project. Each update will involve a summary of work completed the previous period, work being performed the current period, work anticipated the following period, and any important information that may impact the community. We will provide these updates bi-monthly, at a minimum, but more frequently as dictated by construction activities. Thanks in advance for everyone's understanding and patience through this process.


