Recreation & Parks Commission Interviews

Each candidate will be given sufficient time to respond to the questions. At the conclusion of the group interviews, each Councilmember will complete a prepared ballot that the City Manager and City Clerk will tabulate and then report the results of the balloting at the public meeting. Each Councilmember will vote for up to three candidates. Candidates receiving the highest number of votes from at least three (3) Councilmembers shall be appointed. **NOTE: There are two (2) full-terms of office available for appointment and one (1) unexpired term.** The results of each individual Councilmember's vote will be a matter of public record and will be made available to the public upon request pursuant to the Ralph M. Brown Act and the Public Records Act.
