# 12.1 Approve the Bid from AllSport America to Resurface the Tennis Courts and Construct 4 New Pickleball Courts with an Option for Lighting at Lions Park (CIP #42347) (Mr. Zeller)

## Resolution No. 9205

The Director of Community Services presented the item and responded to Council questions. Public comment was received from Ryan Carter, Sara Pender, Bob Hansen, and Helen (no last name given).

Following Council discussion, the City Attorney recommended that, in addition to approving the resolution, the Council make a finding that the project is exempt from CEQA pursuant to guideline section 15301, and direct Staff to file a Notice of Exemption.

It was then moved by Vice-Mayor Neau and seconded by Councilmember Yarbrough that the City Council adopt a resolution authorizing the Director of Community Services to negotiate and execute an agreement with Allsport America for design/build services for new pickleball courts and resurfacing of the existing tennis courts at Lions Park (CIP #42347) in the amount of \$318,720, approving budget appropriations totaling \$339,720, and make a finding that the project qualifies for an exemption pursuant to Section 15301 of the California Environmental Quality Act State Guidelines.

The City Attorney clarified for the record that, although Councilmember Clerici had mentioned he and Councilmember Neau live in proximity to the tennis courts, there is no conflict of interest as they do not reside within 500 feet of the project.

Vice-Mayor Neau reported that the Board appointed an Interim Executive Director, authorized recruitment for the Executive Director position, and adopted the Operating and CIP budgets.

# • El Dorado County Transportation Commission

Councilmember Clerici reported that the Commission received an informational item on the Greater Placerville Wildfire Evacuation Preparedness Community Safety and Resiliency Plan Draft Existing Conditions Report, which he encouraged the public to examine as it contains information regarding preparedness and community safety, such as fire behavior, and local road systems (including inadequate bridges), and said more modelling and recommendations to the report are underway.

Councilmember Clerici reported he attended a meeting where the state of the county's fire protection districts was discussed, and a presentation was received regarding Cityhood and how a city becomes a city through the LAFCO process.
