10.3 Consideration of a Request from the City of Placerville to: (1) Amend Title 10 (Zoning) of the Placerville City Code to Address Required 2021-2029 Housing Element Implementation Program B-7 (Family Daycare Homes) to Comply with California Health and Safety Code Section 1597.45 (File: ZC 24-03) (Mr. Rivas)

The Director of Development Services presented the item and suggested the addition of language following the definitions of Small Family Daycare Home and Large Family Daycare Home (10-1-4) to include, "subject to licensing by the Community Care Licensing Division of the State Department of Social Services." Public comment was received from Sue Rodman.

Following Council discussion, it was moved by Vice-Mayor Clerici that the City Council waive the first reading and introduce an ordinance amending Title 10 of the Placerville Municipal Code Zoning Ordinance as follows: Amending Code Sections 10-1-4 (Definitions, including the suggested language regarding licensing), 10-5-4 (RE, Estate Residential), 10-5-5 (R-1A, Single-Family Acre Residential), 10-5-6 (R-1, 20,000 Single-Family Residential), 10-5-7 (R-1, 10,000 Single-Family Residential), 10-5-8 (R-1, 6,000) Single-Family Residential, 10-5-9 (R-2, Low Density Multi-Family Residential), 10-5-10 (R-3, Medium Density Multi-Family Residential), 10-5-11 (R-4, High Density Multi-Family Residential), and 10-5-12 (R-5, Very High Density Multi-Family Residential) of Title 10.
