**A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF PLACERVILLE APPROVING A CONSTRUCTION CONTRACT WITH  
DOUG VEERKAMP, INC. IN THE AMOUNT OF \$79,297.05, AUTHORIZING THE  
CITY MANAGER TO EXECUTE THE SAME, AND AUTHORIZING THE CITY  
MANAGER TO NEGOTIATE ANY UNFORESEEN AND NECESSARY CONTRACT  
CHANGE ORDERS FOR A NOT-TO-EXCEED AGGREGATE AMOUNT OF \$8,000,  
AND APPROVING A \$56,297 BUDGET APPROPRIATION FROM THE GAS TAX  
FUND UNASSIGNED FUND BALANCE FOR THE LOWER AIRPORT ROAD  
ASPHALT REHABILITATION PROJECT (CIP #41908)**

**WHEREAS**, the Public Works Department desires to improve the current Pavement Condition Index of Lower Airport Road and;

**WHEREAS**, the City's Pavement Management Program cites a poor to failed Pavement Condition Index (PCI) on Airport Road from Goldman Lane to the Broadway and;

**WHEREAS**, the City solicited informal bids from contractors and received the lowest bid from Doug Veerkamp General Engineering, Inc. in the amount of \$79,297.05 for the said project.

**WHEREAS**, the City has determined that an additional \$56,297 budget appropriation from the Gas Tax Fund unassigned fund balance is necessary in order to complete the project:

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Placerville does hereby:

1. Approve a construction contract with Doug Veerkamp General Engineering, Inc. in the amount of \$79,297.05 for the Lower Airport Road Asphalt Rehabilitation Project (CIP #41908); and
2. Authorize the City Manager to execute the same; and
3. Authorize the City Manager to negotiate any unforeseen and necessary Contract Change Orders for a not-to-exceed aggregate amount of \$8,000; and
4. Approve a budget appropriation from the Gas Tax Fund unassigned fund balance in the amount of \$56,297 for the said project.
