4. ADOPTION OF THE MINUTES OF THE MEETING OF January 17, 2022:

- 8. DISCUSSION ITEMS:
 - a. **Business Outreach Visits (Kaiserman, Miller, Windle):** On Hold due to COVID-19 Pandemic.
 - b. Tourism (Anderson, Thomas, Clerici): Member Anderson reported that a "day of cleanup" or day of "community service" is scheduled for April 2022 and should be advertised; recommends that the City's historical assets better accessible on the City's website. The Committee discussed the historic inventory prepared by Dan Morris that is currently on the City's

website. Member Anderson reported that he is working with Andrew Vonderschmitt regarding a memorial located near his office (496 Main Street) and on the "Save the Graves" community events.

c. Broadband Service (Thomas, Kaiserman)

- 1. Update on Project Mr. Morris reported that staff is working with the consultant on the pilot project and will bring the project to Committee for review.
- d. Request from Council to review three items. Review response and action taken by City Council.
 - Downtown Events: Mr. Morris reported on the City Council action on January 25, 2022 for the City to assume oversight of all Downtown Events. The City will be looking for sponsors.
 Public comment was heard from Ruth Michelson.
 - Downtown Outdoor Dining: Mr. Morris reported on the City Council's action on January 25, 2022 was to end any further consideration of outdoor street dining. Mr. Zeller and Mr. Rivas will be looking at a location for the City's parklet this spring. Member Clerici explained that the current zoning ordinance allows for a special temporary use permit for sidewalk dining.
 - **Formula Businesses:** Mr. Morris reported on the City Council item on January 25, 2022 which was tabled to February 8, 2022. The Council directed that no further action will be taken on this issue and no staff time is to be devoted on this issue. **Member Windle** stated that some business owners did no see the survey form and that this issue will continue to come up time and time again. Public comment was heard from Ruth Michelson.
- e. **Review Final Economic Development Strategy and Prioritize Implementation:** Mr. Morris reported on the Council action on February 8, 2022. Council directed that PEAC take a more active role with staff taking a more passive role. PEAC to identify three strategies to pursue.

The Committee recommended that the names of the organizations be removed from Strategy 2.3. Mr. Morris recommended adding tours and historic site inventories to Strategy 2.3.

Following Committee discussion, the following subcommittees were tentatively identified:

- Kaiserman and Miller: Business Outreach
- Kaiserman and Thomas: Broadband
- Anderson, Thomas, and Miller: Site Inventories



- Anderson and Windle: Historic Inventory and Tours
- Clerici and Kaiserman: City Annexations

The subcommittees strategy focus groups will be placed on each agenda each month to report back.

- **b.** Cannabis Dispensaries Update: Mr. Morris updated the Committee on the status of three permit awards and the status of Reserve House's (JSCR Management) extension of time request which was denied by the City Council on January 25, 2022.
- c. SACOG Civic Lab-Broadway Corridor Housing Opportunities Analysis: Mr. Morris updated the Committee on the City's award of \$100K REAP funding from SACOG for consulting services (EPS and Accent Environmental) to perform a housing opportunities analysis. Staff will have a check-in Teams meeting with the consultants on January 17, 2022
