A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF PLACERVILLE RECOGNIZING ANDREW SCOTT PAINTER, CITY PLANNER, FOR 20 YEARS OF PUBLIC SERVICE WITH THE CITY OF PLACERVILLE DEVELOPMENT SERVICES DEPARTMENT, PLANNING DIVISION

**WHEREAS,** Andrew S. Painter began his service to the City of Placerville on August 27, 2001, when he started his position as an Associate Planner with the Planning Division of the Community Development Department; and

**WHEREAS,** Andrew was promoted to the position of City Planner on April 28, 2006, heading the Planning Division; and

WHEREAS, Andrew began his academic career at California State University, Chico with a major in Recreation Administration and, after extensive world travel, touring the western United States fishing and river rafting, Andrew found himself back at Chico State to pursue a Master of Rural and Town Planning degree; and
