FILE: Site Plan Review (SPR) 15-04-R and Variance (VAR) 22-02

**REQUEST:** Consideration of request to revise the previously approved Site Plan Review (SPR)

15-04 (Outbreak Brewing) for building and site improvements to accommodate Burning Barrel Brewery / Distillery. Proposed changes include, but are not limited to, the following: modification of landscaping plan, maximum occupancy, addition of outdoor patio seating, signage, exterior color scheme, and addition of a distillery onsite. Additionally, this request includes a Variance to the on-site parking requirements, where 33 spaces are required for the proposed occupancy and 14

spaces are provided.
