4. 3001 Jacquier Road – Site Plan Review 21-03, Variance 21-01 & Variance 21-02

Consideration of a Site Plan Review and Variance requests by Apple Hill Hospitality LLC, Applicant, and Brett Miller – Eat.Drink.Sleep, Developer:

- 106 room hotel including: meeting facilities, guest dining, parking, landscaping and miscellaneous roadway improvements;
- a variance request to allow an average building height of 46 feet 7 inches in lieu of 40 feet in a Highway Commercial Zone; and
- a parking variance to allow a total of 44% compact parking stalls in lieu of 20%.

The subject site is 3.01 acres generally located north of the intersection of Highway 50 and Point View Drive between Cardinal Drive and Smith Flat Road. Assessor's Parcel Nos. 048-

290-042 (hotel) and -044 (parking); and 2821 Jacquier Road, Assessor's Parcel No. 048-210-038, a 13.71 acre site to contain a 6.6 acre storm water detention basin.

Environmental Document: Mitigated Negative Declaration (SCH# 2003082130) previously adopted for the previously approved hotel projects (Holiday Inn Express and the Hampton Inn and Suites) on the subject sites and shall remain applicable for this request


