

A PROCLAMATION OF THE CITY COUNCIL OF THE CITY OF PLACERVILLE PAYING HONOR TO AND CELEBRATING THE 38-YEAR CAREER OF JAMES T. WHIPPLE

- **WHEREAS,** James was born in Arlington, VA on October 1, 1954; and as a military child, James lived in many different countries growing up; and
- **WHEREAS,** James was a high school and college wrestler, and lettered in 5 sports in high school; and
- **WHEREAS,** he was accepted into 5 different universities and chose Chico State University for his Bachelor's Degree and received a Master's Degree in finance from the University of Washington; and
- **WHEREAS,** James met his wife, Deborah, while they were in college and have been married since 1979; and
- **WHEREAS,** James traveled to Africa to adopt a child and ended up adopting two sons, carrying them home in his arms on the 58 hour plane trip; and
- **WHEREAS,** James and Deborah now have two grown sons, one grown daughter and one grand-daughter; and
- **WHEREAS,** James started his career in healthcare as the Controller at Rideout Hospital in Marysville where he worked for 3 years; and
- **WHEREAS,** James was hired as the Chief Financial Officer for Marshall Medical Center in January, 1982, by then-CEO Frank Nachtman; and
- **WHEREAS,** James and Frank worked together for 22 years and when Frank retired, James was promoted to the CEO of Marshall Medical Center in October, 2002; and
- **WHEREAS,** during James's tenure at Marshall Medical Center, Marshall Hospital grew from 90 beds to 125 beds and opened 20 clinics around the Western Slope of El Dorado County; and
- **WHEREAS,** when James joined Marshall Medical Center, it employed roughly 360 employees and, today, Marshall Medical Center employs nearly 1,700 people in its many facilities around the Western Slope; and
- **WHEREAS,** under James's leadership, Marshall Medical Center was recognized with a CMS 5-Star for Overall Hospital Quality in 2018; Healthgrades

top 10% Hospital in the Nation for Outstanding Patient Experience in 2018; and American Heart Association's Stroke Gold Plus in 2015 and 2017; and

WHEREAS, James served as an at-large trustee on the California Association of Hospitals and Health Systems (CAHHS) Board of Trustees from 2009-2014; and

WHEREAS, James's clear-eyed vision and steady hand have ensured the financial stability of one of California's last not-for-profit, independent hospitals

and leaves a legacy of high-quality, compassionate care for El Dorado County residents and visitors for the next generation to continue; and

WHEREAS, James has always unselfishly given of his time often performing not only his duties but that of other employees at Marshall when they were not available; and

WHEREAS, under James' leadership, Marshall Medical Center has developed a culture of compassion and caring that extends from its patients to its staff and is the envy of other healthcare providers; and

WHEREAS, during his tenure at Marshall, James has always emphasized the health needs of the residents of Placerville and the Western Slope of El Dorado County:
