A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLACERVILLE ENDORSING THE INSTALLATION OF TRANSPORTATION ART UPON THE PIER WALL AT THE U.S. HIGHWAY 50-MOSQUITO ROAD UNDERPASS LOCATED WITHIN THE CITY OF PLACERVILLE

WHEREAS, the County of El Dorado Health and Human Services Agency (HHSA) has engaged in a collaborative effort with the County Public Health Division, The El Dorado Arts Council, and The Boys and Girls Club in developing the Public Health Mural Project; and

WHEREAS, the Mural Project will highlight four focus areas in the County's Community Health Improvement Plan (CHIP) including: Active Living, Healthy Eating, Access to health Care; and Behavioral Health; and

WHEREAS, the Mural Project, as "public art," is a tool for fostering community revitalization, promoting social connections; enhancing community identity and character; and enriching the physical environment; and

WHEREAS, community outreach and support included: the Placerville Downtown Association, El Dorado County Transportation Commission, the County Health and Human Services Agency, the El Dorado Arts council, the Boys and Girls Club, the El Dorado Community Foundation, Marshall Medical Center, Placerville Rotary, El Dorado Transit Authority, El Dorado County Chamber of Commerce, Sacramento Area Council of Governments, and the County Community Development Agency Transportation Division; and

WHEREAS, the mural is to be located on the east side of the pier wall (facing Mosquito Road) at the Mosquito Road-Highway 50 underpass adjoining the El Dorado Trail; and

WHEREAS, the pier wall is a Caltrans' facility located in the Caltrans's right-of-way and therefore requires an encroachment permit from Caltrans and approval of a Caltrans "Transportation Art" application; and

WHEREAS, the Mural Project includes graphic artwork and is proposed to be placed upon Caltrans's property located at the Mosquito Road Under-Crossing, thereby meeting Caltrans' criteria for "Transportation Art"; and

WHEREAS, the pier wall is located within the incorporated area of the City of Placerville and the Caltrans Transportation Art application requirements include a resolution from the local public agency approving the content of the proposed Transportation Art; and

WHEREAS, the mural would become the property of the State of California and having a 20-year lifespan; the long-term maintenance of the mural is ensured subject to an agreement between the County of El Dorado and the State of California; and

WHEREAS, the installation would take place over a two month period in 2018; and

WHEREAS, funding for the mural project has been secured through the County Public Health Division, the El Dorado Arts Council, and the El Dorado Community Foundation; and

WHEREAS, at its regular scheduled meeting on March 13, 2018, the City Council following consideration of the proposed mural and public comment, directed the project proponents to

consider modifications to the mural adding elements that recognize the local area's history, customs and character; and

WHEREAS, the proposed mural as modified, is more definitively reflective of the local area's culture, custom, and history through the incorporation of recognizable buildings, structures, period costume, and animals.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Placerville approves of the content of the proposed Transportation Art and supports the Transportation Art Mural Project as shown in Exhibit A attached hereto.
