A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLACERVILLE
ADOPTING A MITIGATED NEGATIVE DECLARATION FOR THE
PLACERVILLE STATION II PROJECT (CIP #40708), THE MOSQUITO ROAD
OVERLAY PROJECT (CIP #41820), AND THE MOSQUITO ROAD SEWER MAIN
REPLACEMENT PROJECT (CIP# 41823), APPROVING SAID PROJECTS, AND
AUTHORIZING STAFF TO PREPARE AND RELEASE A REQUEST FOR
PROPOSALS FOR CONSTRUCTION MANAGEMENT SERVICES FOR THE SAID
PROJECTS

WHEREAS, the Placerville Station Phase II Park-N-Bus Improvement (CIP #40708) is a project to construct the second phase of the park and ride facility immediately south of the existing Phase I facility located at the southwest corner of Mosquito Road and Clay Street; and

WHEREAS, construction of the Park-N-Bus Phase II facility (CIP #40708) will be funded by and build in accordance with a Federal Transportation Administration Section 5309 grant; and

WHEREAS, proposed roadway, sewer, water, and storm drain improvements (CIP #41820 & #41823) adjacent to the Park-N-Bus facility on Mosquito Road, Locust Drive, and Clay Street will be constructed using Measure H/L local funds; and

WHEREAS, at its February 5, 2014 meeting the California Public Utilities Commission (CPUC) approved an exemption from the undergrounding rules when relocating utilities within a scenic corridor; and

WHEREAS, the Mitigated Negative Declaration and Initial Study was circulated for a 30-day public comment period beginning on August 17, 2018 and ending on September 17, 2018; and

WHEREAS, the comments received were considered and mitigation measures have been incorporated in the Mitigated Negative Declaration mitigating any potential environmental effects to a point where no significant effects would occur with project implementation; and

WHEREAS, due to the size and scope of the project, current workload, and limited staff, it is necessary to seek proposals from qualified construction management firms to assist the City with providing services related to finalizing the bid documents, bid support, management of construction activities, quality assurance, quality control, materials testing, invoicing, labor compliance, and project close out of this federally funded project.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Placerville does hereby:

- 1. Adopt the Mitigated Negative Declaration and Mitigation Monitoring Program prepared for this project pursuant to the provisions of the California Environmental Quality Act (CEQA) finding that there is no substantial evidence that the proposed project will have a significant effect on the environment and that the Mitigated Negative Declaration reflects the City Council's independent judgment and analysis; and
- 2. Approve the Placerville Station Phase II Park-N-Bus project (CIP #40708), Mosquito Road Overlay project (CIP #41820), and the Mosquito Road Sewer Main Replacement project (CIP #41823); and
- 3. Authorize staff to prepare and release a Request for Proposals for Construction Management Services for the said project.
